I received your advice today that your engine 1676 was now at South Tacoma awaiting arrival of Bailread's inspector, and Mr. Kinsell is leaving here by plane today and expects to be in Tacoma February 26th to start on his work.

It was mighty nice of you to help us out at this time as we are badly in need of additional locomotives.

We placed an order with the Baldwin Locomotive Works for a locomotive last May and was advised about three weeks ago that all of the material had been massived except plates for which I have since received priority but this engine will not be finished until sometime in July and delivered in August.

I also appreciate your advice combained in your letter of February 13th that your forces at South Tacosa will dismantle the engine and parts boxed and shipped as may be directed, all additional expense after acceptance of the engine to be assumed by The Alaska Railroad.

Mr. Kinsell has been requested to arrange necessary details with the Superintendent of the South Tacoma Shops; also to give aliettmest order of the various items, including the tender, which can be moved on it's own wheels from South Tacoma to Scattle.

Dear Sir:

I am in receipt today of invitation, bid and acceptance, (short form contract) covering the purchase by the Department of the I terior for the Alaska Railroad of Northern Pacific engine 1676, and have arranged for Purchasing Agent Willis to complete this form and return to Mr. Ummel immediately.

The form calls for a quotation f.o.b. Seattle and we are advising Purchasing Agent Ummel that at your request we are moving the engine to South Tacoma where it will be dismantled and boxed for shipment in conformity with the directions of a representative of the Alaska Railroad and the parts delivered f.o.b. dock trackage at Seattle, the Government to assume the cost of dismantling, boxing and loading the parts, in addition to the price quote f.o.b. dock trackage.

The last sentence of Specification form M-3155 attached to the invitation stipulates "Locomotive to be knocked down for export shipment to Seward. Boiler removed from frame and cylinders and driving wheels and trucks removed from engine frame, all smaller parts removed and to be boxed." "F.O.B. cars, Pier, Seattle, Wash."

Nothing is said about re-imbursing us for the expense of knocking down and boxing the parts for shipment, and as we are unable to make a reasonably accurate estimate of the cost, it seems to me it would be more satisfactory to quote Purchasing Agent Ummel the price we quoted you for the engine delivered on it s own wheels, with the understanding that the knocking down, boxing and loading for shipment will be an extra charge. If this is not satisfactory we will make the best estimate we can of the cost of knocking down and add this to the purchase price quoted.

It so happened that on receipt of your inquiry we had stored at Parkwater engine 1676 which had just been outshopped at South Tacoma.

With the enormous increase in volume of business incident to the defense movement we expect to be very tight on power next fall and had, of course, planned to use this engine to help us over the peak. We are about to purchase additional power but cannot get delivery in time to be of any service this year, and that I think would have also been true had the Alaska Railroad undertaken to place an order for a new engine at this time. Prices are also extremely high.

However, we are glad to accommodate you with the 1676 which I should judge would be just about what you need for your track and operating conditions, and should give you many miles of service before it will require another back-shopping.
